### **EXPORTS**

- Manufacturing Circle Trade Survey conducted in March, assisted by the Tutwa Consulting Group
- Information gathered will guide us in identifying opportunities for export-led growth and import replacement. We will also be better enabled to communicate the impact of trade agreements and tariffs on member's manufacturing operations
- The survey will also inform our planning for the Export Forum to be held in October 2022
- A good response rate was received, analysis is currently being finalised for distribution in due course

- Manufacturing Circle South African Renewable Energy Material Demand Study finalised and distributed in February
- Steel Master Plan Local Demand Workstream meetings continue to be chaired by the Manufacturing Circle on a monthly basis

- Opportunities for localisation continue to be assessed together with BUSA's newly appointed Localisation Project Manager
- Current areas of focus comprise steel, medical products and clothing, textiles, leather and footwear

- We noted our concerns regarding the omission of any mention of local content and offered to avail ourselves for further discussion to drive the collaborative approach required to develop and implement a practical solution to leverage public procurement
